This Model Release Agreement (the "Agreement") is made and entered into this _____ day of _____, 2023 (the "Effective Date"), by and between Three Cycle Media LLC (the "Photographer") and _____ (the "Model"), whose date of birth is ____ / ____ / ____.

Grant of Rights: The Model hereby grants the Photographer and their legal representatives, assigns, and those acting under their authority, the unrestricted right and permission to copyright and/or use, and/or publish, and/or sell photographic portraits or pictures of the Model, or in which the Model may be included, in any manner or media, whether now known or hereafter created, anywhere in the world, for any purpose.

Waiver: The Model hereby waives any right to inspect or approve the photographs or electronic matter that may be used in conjunction with them now or in the future, whether that use is known or unknown, and the Model waives any right to royalties or other compensation arising from or related to the use of the photographs.

Release: The Model hereby releases and discharges the Photographer, their agents, representatives, employees, and any third parties acting under the Photographer's authority from any claims, liabilities, demands, actions, causes of action, costs, and expenses, at law or in equity, whether matured or unmatured, whether known or unknown, arising out of or in connection with the use, exploitation, or distribution of the photographs.

Digital Manipulation: The Model acknowledges and agrees that the photographs may be digitally stored and manipulated and waives any right to inspect or approve the finished product. The Model agrees that the Photographer has the right to create, use, and modify the photographs for commercial purposes, including but not limited to, retouching the photos, adding special effects, altering their size, and cropping, as the Photographer deems appropriate. The Model understands and agrees that the Photographer has the full right to sell, reproduce, or redistribute the images, either separately or together, partially or in total, digitally manipulated or otherwise, for any commercial purpose, including but not limited to advertising, art, editorial sales, and any other Photographer marketing.

This Agreement shall be binding upon the Model, and the Model's successors, legal representatives, and assigns.
